What Can You Do to Advocate?

A quick guide on advocating for services, supports, and protections for child sex trafficking victims. Here are options of what you can do to make a difference!

1. Learn more!

Request a training or a speaker from Georgia Cares!

 Become educated and informed on the issue of child sex trafficking by requesting a training or speaker from us! Click <u>here</u>.

2. Talk About It!

- Talk to your friends, family, co-workers, and anyone else in your community about the issue of child sex trafficking. Share research and statistics you know.
- Use any opportunity to bring light to this horrific crime- talk about it at your Bible Study, inform parents you know, tell your pastor, discuss it at your civic group. The opportunities for sharing this information with those you come in contact with on a daily basis are endless!
- Share specific pieces of legislation with those in your community, so they can be educated too!
